- 2008 data on GDP growth rate for Cambodia, Myanmar and Lao PDR 2008 are based on GDP estimates published in the IMF WEO Database October 2009. ASEAN figure is estimated using country growth rates and country share of world GDP valued in PPP\$ from the IMF WEO Database October 2009.
- The official foreign exchange rate in Myanmar in 2008 was Kyats 5.43/US\$. The exchange rate used in ASEAN statistical databases is derived from the IMF WEO Database October 2009 which is Kyats 1,102.8=US\$1. Significant change for Lao PDR currency as the government the presidential decree on currency management that encourage people use and advertise prices of goods in Lao Kip.
- Figures for Brunei Darussalam, Indonesia, Malaysia, the Philippines, Singapore, Thailand and Viet Nam are for 2008, while those for Cambodia, Lao PDR and Myanmar are for 2005.
