## FRAMEWORK OF THE STRATEGIC PLAN OF ACTION FOR THE ASEAN COOPERATION ON ORGANIC AGRICULTURE (2014 to 2017)

#### **Background and Rationale**

The Declaration of the ASEAN Economic Community Blueprint provides a roadmap for transforming the ASEAN into a single market and production base, highly competitive and fully integrated into the global market mechanism by 2015. Similarly, ASEAN has issued a Declaration on Environmental Sustainability, with a firm commitment to strengthen cooperation over a wide range of activities including highlighting the issues of conservation and sustainable management of natural resources.

Enhancing food security and food safety while ensuring environmental sustainability defines the scope and perspective in the development of the food and agriculture sector in ASEAN as outlined in the ASEAN Economic Community (AEC) Blueprint. Under this framework, development of organic agriculture will be treated as equally important in both economic and environmental perspectives.

The Special SOM-33<sup>rd</sup> AMAF held on 9-10 July 2012 in Yogyakarta, Indonesia has agreed on the formation of a Special Experts Group to initiate an ASEAN Standard for Organic Agriculture. The initiative on developing an ASEAN Standard on Organic Agriculture and a corresponding Strategic Plan of Action are critical to ensure market competitiveness and to provide guidance on the quality determination in the international and/or regional markets.
