CUSTOMS DUTIES (GOODS OF ASEAN COUNTRIES ORIGIN)
(COMMON EFFECTIVE PREFERENTIAL TARIFF)
(EXEMPTION) (AMENDMENT) ORDER 2006

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as **Customs Duties (Goods of ASEAN Countries Origin) (Common Effective Preferential Tariff) (Exemption) (Amendment) Order 2006**.

(2) This Order comes into operation on **18 August** 2006.

Amendment of Schedule C

2. The Customs Duties (Goods of ASEAN Countries Origin) (Common Effective Preferential Tariff) (Exemption) Order 2002 [P.U.(A) 118/02] is amended in Schedule C –
